Theme of the Conference: Advancing Comprehensive Sexuality Education (CSE) to achieve Sustainable Development Goals 2030

Background

The world now has more young people than ever before. Adolescent is an important stage of human development and is an important asset for the country. Healthy adolescents support at present as an important workforce, create healthy adulthood community in future and delivering healthy baby in next generation. Generally, they are healthy and productive as compare to other groups but they also face a lot of risks and challenges when it comes to social and political participation, access to sexual and reproductive health information and services. Young people are more vulnerable to multiple sexual and reproductive health problems, ranging from early and forced marriage, unsafe sex, early and unwanted pregnancy, early child bearing and sexually transmitted infections including HIV. In addition, young women and girls are more vulnerable to violence including sexual violence and suffers from various forms of harmful practices perpetuated by patriarchal socio-cultural norms and values and taboos around sexuality. It is said that the strategic investments in adolescents' health and well-being have economic and social benefits amounting to 10 times more than they cost, save 12.5 million lives, prevent more than 30 million unwanted pregnancies, and prevent widespread disability.

Government of Nepal has made global commitments to realize the 2030 Agenda and the Sustainable Development Goals (SDGs), specifically SDG 3 on health and well-being, SDG 4 on quality education and SDG 5 on gender equality and women's empowerment and its specific target of ending GBV and harmful practices against women and girls. The School Sector Development Plan (SSDP) 2016-2023, has aimed to strengthen participation and minimizing the adolescent girls drop-out rate by fulfilling their privacy and menstrual hygiene management related needs. The School Education Sector Plan 2022-2030, continues the policy of Nepal Government to implement CSE in schools.

Rationale1

Children and young people have a right to receive accurate, scientifically comprehensive information about sexuality education. However, teaching about sexuality in schools is a sensitive subject. Parents, religious leaders, and politicians have been debating how much and what should be taught at what age frequently in extremely polarized debates.² It is believed that a good education assists young people in gaining the knowledge, skills, and ethical values necessary to make informed and healthy decisions about relationships, sex, and reproduction.

Even though there are signs that early marriage is on the decline, 28.8% of 15-19-year girls are already married. Men's median age at first sexual intercourse is one year younger than their median age at first marriage (17.9), whereas women's median ages at first marriage and first sexual intercourse are the same. More than half (51%) of women aged 25 to 49 had their first sexual intercourse by the age of 18, and 71 percent had their first sexual intercourse by the age of 20. These high proportions indicate a high likelihood of pregnancy early. The age-specific fertility rate in the 15-19 age group is 88 births per 1,000 women, up from 81 births per 1,000 women in 2011(*NDHS 2016*). This Most importantly, adolescent fertility rate is much higher i.e., 288/1000 among married adolescent as show by a

recent analysis of in 2020³. These indicators show significant efforts are needed to achieve SDG goal of AFR 30/1000 by 2030.

- 1. The abstract should address one of the tracks mentioned above. Please choose <u>the track</u> which best describes the subject of your abstract in the abstract form.
- 2. The text of the abstract should not exceed 250 words (in Times New Roman font size 11pts).
- 3. The abstracts should be submitted in the prescribed abstract form provided. Abstracts can be submitted both in English and Nepali languages.
- 4. Abstracts should be sent by mail to Conference Secretariat, Family Planning Association of Nepal (FPAN), *Pulchowk, Kathmandu in following address:* abstractnccsenepal@fpan.org.np
- 5. The deadline for abstract submission is <u>30 November</u>, <u>2022</u>.
- 6. The abstract should cover the following:
 - a. <u>Background:</u> general introduction and the study objectives, the hypothesis tested, or a thorough description of the problem/issue;
 - b. <u>Methods:</u> materials and methods used to collect information, analysis of issues, use of statistical procedure and/or the specific statistical packages(software), if used in analysis, approach and intervention;
 - c. Results: specific results, discussion, and conclusion(s) drawn, summarize the main outcome.
 - d. Lesson learned/recommendation/implication
- 7. This guideline and abstract form will be available at FPAN website (*www.fpan.org*)(link will be added once it is created). You can also choose to submit your abstract directly to the website.
- 8. Your abstract, if accepted, will appear in its full form in the abstract book.
- 9. An independent review panel will review the abstracts for selection. The committee reserves all rights to assign any accepted abstract for oral or poster presentation. The committee also reserves the right for rejection of any submitted abstract.
- 10. Notification of acceptance or rejection will be sent to the corresponding author by <u>December 15th, 2022</u> by email.
- 11. The organizing committee will not be responsible for scholarships even to participants with accepted abstracts. He/she is advised to make his/her own financial coverage for participation.
